Waiver, Release of Liability, Indemnification and Hold Harmless Agreement:

I am granting my son/daughter (“Participant”) permission to participate in this ongoing volleyball activity including lessons, games, practices and any related volleyball activity (“Activity”) organized by Madison Inferno Volleyball Club. In consideration for being allowed to participate in this Activity, I release from liability and waive my right to sue Madison Inferno Volleyball Club, their employees, owners, officers, contractors, volunteers, agents, and representatives (collectively “Club”) from any and all claims, including claims of the Club’s negligence, resulting in any physical injury, illness (including death) or economic loss I may suffer or which may result from my participation in this Activity, or any events incidental to this Activity. I also release from liability and waive my right to sue any facilities or owners of the facilities where the Activity takes place.

I acknowledge that the Participant is voluntarily participating in this Activity. I understand that there are risks associated with their participation in this Activity, such as physical and/or psychological injury, pain, suffering, illness, disfigurement, temporary or permanent disability, or economic loss. These injuries or outcomes may arise from their own or other’s actions, inactions, or negligence, or the condition of the Activity location. Nonetheless, I assume all risks of their participation in this Activity, whether known or unknown to me, including any events incidental to this Activity.

I agree to hold the Club harmless from any and all claims, loss or damage to my or the Participant’s personal property, liabilities and costs, including attorney’s fees, as a result of their participation in this Activity, or any events incidental to this Activity.

Should the Participant sustain an injury or illness while participating in this Activity, I hereby authorize any emergency, first aid, medication or medical procedure deemed necessary to the Participant.

If the Participant needs medical treatment as a result of participation in this Activity, or any events incidental to this Activity, I agree to be financially responsible for any costs incurred as a result of such treatment. I am aware that the Club does not provide any health insurance for me. I further represent that I have adequate insurance to cover any injury, illness or damage the Participant or I may suffer as a result of this Activity. I hereby agree to bear all costs of any such injury, illness or damage myself.

I further represent that my Participant has no medical or physical condition which would interfere with their safety when participating in any Activity or else I assume, and further agree to bear the costs of, all risks that may be created, directly or indirectly, by any such a condition.

The novel coronavirus, COVID-19, has been declared a worldwide pandemic by the World Health Organization. COVID-19 is extremely contagious and is believed to spread mainly from person-to-person contact. The Club has put in place preventative measures to reduce the spread of COVID-19; however, the Club cannot guarantee that you or the Participant will not become infected with COVID-19. Further, attending the Club Activities could increase the Participant and your risk of contracting

COVID-19. By signing this agreement, I acknowledge the contagious nature of COVID-19 and voluntarily assume the risk that the Participant and I may be exposed to or infected by COVID-19 by attending the Club Activities and that such exposure or infection may result in personal injury, illness, permanent disability, and death. I understand that the risk of becoming exposed to or infected by COVID-19 at the Club may result from the actions, omissions, or negligence of myself and others, including, but not limited to, Club employees, owners, officers, contractors, volunteers, agents, and representatives and their families. I voluntarily agree to assume all of the foregoing risks and accept sole responsibility for any injury to my Participant or myself (including, but not limited to, personal injury, disability, and death), illness, damage, loss, claim, liability, or expense, of any kind, that I or my Participant may experience or incur in connection with my Participant's attendance at the Club or participation in Club Activities. On my behalf, and on behalf of my Participant, I hereby release, covenant not to sue, discharge, and hold harmless the Club, its employees, owners, officers, contractors, volunteers, agents, and representatives, of and from the claims, including all liabilities, claims, actions, damages, costs or expenses of any kind arising out of or relating thereto. I understand and agree that this release includes any claims based on the actions, omissions, or negligence of the Club, its employees, owners, officers, contractors, volunteers, agents, and representatives, whether a COVID-19 infection occurs before, during, or after participation in any Club Activities.

I agree to allow the Club to take photos and videos of my Participant in any Activity put on by the Club and use those photos, images and video on the Club's website, various social media posts and other Club related activities including all marketing opportunities.

I am the parent or legal guardian of the Participant. I have read this document, and I am signing it freely. I understand the legal consequences of signing this document, including (a) releasing the Club, its employees, owners, officers, contractors, volunteers, agents, and representatives from all liability on my and the Participant's behalf, (b) waiving my and the Participants' right to sue the Club, its employees, owners, officers, contractors, volunteers, agents, and representatives (c) and assuming all risks of Participant's participation in this Activity, or any events incidental to this Activity. I allow the Participant to participate in this Activity. I understand that I am responsible for the obligations and acts of the Participant as described in this document.
